The Association is not responsible for any contribution, opinion, recommendation, content, articles or external links from one of its members nor their further use or misuse on this Group, on LinkedIn, on the Internet or on any other open forum.

## 2. Proper use / Do's and don'ts

Each member can express themselves on the wall of the group, share professional information, initiatives, requests and job offers. On the other hand, this group is not intended to accommodate publicity, and the debates that are likely to take place should respect the principles of the Association concerning in particular its political and religious neutrality.

In accordance, as a member of this group, you agree not to disseminate any information that would promote any political party or a political personality, nor to promote or put forth any religious denomination, opinion or creed.
